



**REASONED ORDER OF THE VICE-CHANCELLOR, L.N. MITHILA UNIVERSITY,  
DARBHANGA IN COMPLIANCE OF THE DIRECTION OF THE HON'BLE PATNA HIGH  
COURT DATED 02.11.2010 IN C.W.J.C. No. 9906/2010 (MITHILA TEACHERS TRAINING  
COLLEGE, BASUARA, DISTT. – MADHUBANI V/S. THE STATE OF BIHAR & ORS.)**

1. Perused the order dated 02.11.2010 of the Hon'ble Patna High Court in CWJC No. 9906/2010 (Mithila Teachers Training College, Basuara, Dist. – Madhubani V/s the State of Bihar & Ors.

As directed by the Hon'ble Court, also perused the judgement of the Hon'ble Supreme court of India reported in (2006) I SCC 1 (State of Maharashtra V/s. Sant Duyaneshwar Shikshan Shastra Mahavidyalaya & Ors.

2. Also perused letter no. ERC/7-99.6(I).9/2009/921 dated 30<sup>th</sup> July, 2009 of the NCTE, ERC, Bhubaneshwar (Annexure 1 of the writ petition) as well as representation of the petitioner College (Annexure – 4 & 5).
3. The University had already granted permission for admission of students to 1 year B.Ed. course for academic session 2011-12 in compliance of order of the Hon'ble Court in L.P.A. No. 382/11 with I.A. No. 6191/2011.


In view of the facts stated above and after considering the representation of the petitioner college, I hereby order the following in compliance of the direction of the Hon'ble Court dated 02.11.2010 in CWJC No. 9906/2010.

"Since, the N.C.T.E., E.R.C., Bhubaneshwar vide its letter no. ERC/7-99.6(I).9/2009/921 dated 30<sup>th</sup> July, 2009 has granted recognition to Mithila Teachers Training College, Basuara, Distt. – Madhubani for conducting B.Ed. Course of Secondary Level of One year duration with an annual intake of 100 (one hundred) from the academic session 2009-2010 under clause 7 (II) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject to the conditions laid down therein, and.

Since, the Hon'ble High Court, Patna vide its order dated 02.11.2010 has directed the respondent University to consider the representation filed by the petitioner College in view of the recognition by NCTE,

The petitioner, "Mithila Teachers Training College, Basuara, Dist. – Madhubani is granted permanent affiliation commencing from the academic session 2009-2010 for conducting B.Ed. Course of Secondary level of 1 (one) year duration with an annual intake of 100 (one hundred) students subject to the condition that in case the grant of recognition by the NCTE is recalled in accordance with law, the affiliation shall cease automatically".
